National Services Transition

- South Australia first jurisdiction to transition
 - Investigations, Intelligence and Prosecutions July 2016
 - On-Road Safety & Compliance, Safe-T-Cam, Work Diaries, Access etc

October 2017

 - Tasmania July 2018
 - Core Services July 2018
 - Remaining jurisdictions and services TBA



NHVR Safety & Compliance Operations - SA

- National Safety & Compliance On-Road Operations
 - Driven by NHVR Strategy and Policy
 - Intelligence-led Deployment Plans and Operations
- NHVR Safety & Compliance Officers
 - Directly employed and managed by the NHVR
 - Dedicated training and support program
 - Consistent and coordinated compliance activities and outcomes

National Compliance Information System

- Nationally coordinated On-Road Operations 2017 & 2018
 - Involving all jurisdictions (participating and non-participating)
- National Heavy Vehicle Monitoring Network
 - Additional camera installations and data sharing
- Single National Data and Information Source
 - Allowing NHVR to identify the areas presenting the greatest risk
 - Intelligence-led compliance effort and resource deployment to address those risks
 - Allowing safe and compliant operators to get on with business



Roadworthiness Program

- Objective: to reduce the safety, economic and environmental impacts caused by unroadworthy heavy vehicles.
- > The Program will ensure a nationally consistent approach to HV inspections including:
 - Inspection types
 - Inspector competency requirements
 - identification and management of HV defects
 - data collection
 - > evidence based identification of higher-risk HV vehicles for inspection
- The Program will implement a risk-based approach to ensure adherence to vehicle standards through auditing, monitoring and inspecting heavy vehicles



Roadworthiness Program

- > The first stage was the National Roadworthiness Baseline Survey (NRBS)
 - report released April 2017
 - NRBS provided a comprehensive snapshot regarding the current roadworthiness status of the national heavy vehicle fleet
 - NRBS data is being utilised to inform the RW Program, particularly the Riskbased Inspection Framework
- Risk-based Inspection Framework combines all project elements of the RW Program
- The Risk-based Inspection Framework will be presented to the Transport Infrastructure Council for approval in 2018



Chain of Responsibility – Mid-2018

- Primary Duties
- Vehicle Standards and Maintenance
- The HVNL will be amended to make it clear that every defined party in the supply chain has a "duty" to ensure safe practices, rather than being deemed liable for breaches detected.
